



#### 2019 Guidance

- 2019 Revenues are expected to be solid, estimated \$250k+ (not as strong as 2018)
  - Jan-April 2019 down \$38k on 2018 (\$20k due to timing of 2017 receipts + lower summer bookings)
  - Winter bookings as at 1 May 2019 not as strong as last year but the Board is confident bookings will come
- > Budget for improvements will be around \$50K.
  - The Board will continue to monitor revenues against spend and adjust accordingly. Budget currently includes:
  - General maintenance
  - No major capital works
- Cash Balance as at 1st May 2019 = \$250k versus \$189k this time last year

## Merchandise update

- > Jackets
- > \$18k spend on jackets
- > \$6k made in revenue
- > \$6k worth of jackets at the lodge to be sold
- No plans to renew merchandise for 2019



## Special Resolution

Proposed changes to the maximum number of Life Members

### Special Resolution

- > The purpose of this special resolution is to amend the rules of the co-operative (Rules) to increase the potential number of Life Members of the co-operative from 10 to 20
- That Rule 4.3 which presently reads:
  - 4.3 Life Membership formerly Rule 15B
  - The co-operative at a general meeting of which due notice of the intention so to do has been given may on the nomination of the Board elect members as Life Members of the co-operative.
  - There cannot be more than 10 Life Members of the co-operative at any one time.
  - To be eligible for nomination for election as a Life Member a member must in the opinion of the Board have rendered exceptional services to the co-operative, the co-operative and the former unincorporated association known as the Alpine Club of Kiama, for a period of not less than 10 years.
  - Every Life Member so elected is entitled to all the privileges of the co-operative during his or her life without payment of annual subscriptions or capital levies.
- > The Board's motion will be passed as a special resolution if at least two thirds of valid votes cast in person at the meeting are in favour of the motion

**Motion:** To adopt the proposed special resolution to change Rule 4.3 to increase the maximum number of Life Members of the Cooperative from 10 to 20.

# Findings from Working Group

Tony Lloyd

## Working Group Established

- In 2018 we established a new working group to investigate what viable options exist to purchase/lease a second club lodge in Thredbo, Perisher or similar Australian option or in the future if an opportunity presents itself
- > The group also consisted of
  - Director Phill Deer Lead
  - Treasurer Andrew Wearne
  - Vice-President Tony Lloyd
  - And three of our members who specialise in property development - Mark Fleming, Brett Burridge and Rob Molino

## Findings from Working Group

- We started by looking at the issues driving the brief and found that we were not yet in a position where we needed substantial additional facilities at this time.
   However, we have seen steady growth in both winter and summer bookings over the past decade which we believe will continue.
- We also looked at our financial position and found that we are in a strong position and growing stronger each year.
  - We have completed a number of upgrades on the lodge in the past decade with some improvements yet to come
  - Yet our forecast is for a continued strong surplus position to allow for future opportunities to expand our bed base

## Findings from Working Group

- Developed 7 options to explore in more detail
  - > Buy an existing building (club or commercial lodge) Thredbo/Perisher/Vic
  - > Buy some kind of Timeshare (either on-snow or off-snow)
  - > Extend our building and purchase beds
  - > Buy a freehold commercial lodge on the Alpine Way
  - Merge with another lodge
  - > Buy freehold commercial lodge in Jindabyne
  - > Develop a new site @ Thredbo
- > Review of each option was presented to the Board late last year
- > Recommendation: investigate Option 1 with 5-year timeframe
- Over the next 12 months we will continue our Working Group meetings to develop a business case for review by all members
